HAVING SEEN the decree. no. 327/2024 prot. no. 54213 dated 16/02/2024 with which the public selective procedure was announced, based on qualifications and interview, for the assignment of no. 1 "junior grant" at the "Marco Biagi" Department of Economics – S.S.D. SECS-S/06 (Mathematical methods of economy, finance and actuarial sciences) – Tutor Professor Silvia MUZZIOLI, published in the online noticeboard of the University of Modena and Reggio Emilia;

HAVING SEEN the decree. no. 402/2024 prot. nr. 74388 dated 01/03/2024 with which the deadline for submitting an application to the aforementioned procedure, pursuant to art. 5 of the selection notice, has been extended; GIVEN the deadline of 15.03.2024 - 1.00 pm (Italian time) to apply to the aforementioned procedure, pursuant to art. 5 of the selection notice;

CONSIDERING that no applications have been received until 13.03.2024;

GIVEN the request, advanced by Prof. Silvia MUZZIOLI, to extend the deadline of participation in the aforementioned selective procedure (prot. nr. 85174 dated 13.03.2024);

The deadline for submitting applications referred in the selection of the introduction is changed, **without prejudice to any applications submitted pending publication of this decree.**
