GIVEN the public selective procedure, based on qualifications and interview, for the assignment of no. 1 junior research grant at the Artificial Intelligence Research and Innovation Center (AIRI), Tutor: Prof. Francesco GUERRA, announced with decree of 30 April 2024 prot. no. 112411 - rep. no. 708/2024 and published on the online noticeboard of the University of Modena and Reggio Emilia;

GIVEN the request to modify the terms of participation in the selective procedure, advanced by Prof. Francesco GUERRA (prot. nr. 113081 of 02 May 2024);

GIVEN the deadline of 17 June 2024 - 1.00 pm (Italian time) to submit an application for admission to the aforementioned procedure, pursuant to art. 5 of the selection notice;

**DECREES**

Articles 5 and 10 of the Notice are modified as follows:

*Article 5*

*Application and deadline*

The application for admission to the selective procedure must be drawn up and sent, under penalty of exclusion, using exclusively the PICA - Integrated University Competition Platform - available at <https://pica.cineca.it/unimore/> by 1.00 pm (Italian time) within the peremptory deadline of 15 days starting from the day following the publication of the notice on the University's online noticeboard.

If the indicated deadline falls on a public holiday, the deadline is postponed to the first available working day, pursuant to art. 2963 paragraph 3 of the Civil Code. *omissis*

*Publicity of this selection procedure*

The announcement relating to this procedure will be advertised for a period of no less than 15 days via the INTERNET, on the University's online noticeboard at the link <https://wss.unimore.it/public/albo/> and on the website of the Ministry and the 'European Union.

Therefore, **the new deadline for submitting applications is 17 May 2024 1:00 pm (Italian time).**
