GIVEN the public selection procedure for the awarding of no. 1 Research Contract of two-year duration, pursuant to art. 22 of Law 30.12.2010, no. 240 at the Department of Biomedical, Metabolic and Neural Sciences, announced with decree of September, 11<sup>th</sup> 2025 – prot. nr. 259290 – rep. nr. 618/2025 and published on the online noticeboard of the University of Modena and Reggio Emilia;  
GIVEN the mere clerical error in indicating the the start of activities;  
SEEN the request for rectification, ns prot. nr. 273393 del 25 settembre 2025 e ns prot. nr. 274665 del 26 settembre 2025;  
HAVING RECOGNIZED the need to provide;

**DECREES**

**The amendment of Articles 2, 3 and 7 of the Notice as follows:**

Art. 2 - Admissions requirements

The selection process is open to Italian and foreign candidates who are:

- in possession of a PhD qualification or equivalent obtained abroad or a postgraduate medical specialty qualification, on the deadline for submitting the admission applications
- enrolled in the final year of a PhD course or of a postgraduate medical specialty, **provided that the qualification is expected to be obtained within the mandatory deadline of November 5<sup>th</sup> 2025, to allow the signing of the contract and the start of activities no later than November 6<sup>th</sup> 2025**, it being understood that the signing of the contract is subject to the qualification being obtained, under penalty of forfeiture. [omissis]

Art. 3 - Method and deadline for submitting the application

The application for the participation to the selection procedure must be drawn up and sent, under penalty of exclusion, using exclusively the IT application PICA – Integrated Platform for University Competitions – at the link <https://pica.cineca.it/unimore/>.

The application must be submitted within the peremptory deadline of **October 6<sup>th</sup> 2025, 1:00 p.m. (CET)**. [omissis]

Art. 7 - Interview

**The interview will be held on October, 17<sup>th</sup> 2025 at 10:00 a.m. (CET) in the room “MO15”, 5<sup>th</sup> floor, in via G. Campi 287, Modena.**

**This announcement constitutes a notification of invitation for candidates admitted to the interview.** Candidates who have not been notified of their exclusion from the selection are required to present themselves on the day and at the time communicated. [omissis]
