## 1. Purpose

This Call for Applications is addressed to **non-EU applicants who are not residing in Italy and are applying for a Visa at the Italian diplomatic or consular representations**. Applicants must have a **study qualification obtained abroad** and be willing to enrol in the Master's Degree Programme in INTERNATIONAL MANAGEMENT for the Academic Year 2026-2027.

The places available are **100 in total**, of which 1 is reserved to the applicant who wins the UNICORE 8.0 University Corridors for Refugees 2026-2027 call for applications (subject to the programme being activated, Unimore participating and the winner choosing International Management) available on the website <https://www.unimore.it/it/internazionalizzazione/progetto-unicore>

APPLICATIONS must be submitted **by 20 February 2026** and applicants shall be subject to a verification of their personal training that will be carried out **based on their study qualification with a possible interview by remote**.

Italian and foreign applicants with an Italian study qualification, EU applicants (regardless of their residence), and foreign applicants who are legally residing in Italy and have a foreign study qualification eligible for the enrolment in International Management do not have to apply for admission and follow the instructions in this notice, although they do have to apply for evaluation and follow the procedure described in the call for applications specifically issued for them, which will be published approximately by April 2026.

## 2. Requirements

Applicants are required:

- a) to have a Bachelor's degree deemed suitable (economics, marketing, business administration or management) and **obtained before submitting the application for admission**
- a) to have a language certification of at least level B2 of the Common European Framework of Reference, or **declarations by the home university** (Language Centre or Department) stating that the applicant has reached the required level. These declarations must be drafted on official University letterhead and written in English. A list of the language certificates recognized by UNIMORE is available at the following link <https://www.cla.unimore.it/site/home/certificazioni.html>
- b) to have the European Computer Driving Licence (ECDL - basic level), or alternatively, documentation attesting to computer skills, if not indicated in the degree programme
- c) to have basic knowledge in the following subjects: Business Administration, Marketing, Management, Economics, Statistics and Mathematics, Private Law.
- d) to have a personal preparation and training and professional experience relating to this specific type of Master's degree.
- e) to pay **by 20 February 2026** a mandatory admission fee of 20,00 Euros, non-refundable.

## 3. Submitting an online application

From [www.esse3.unimore.it](http://www.esse3.unimore.it) proceed to "**Registration**" to obtain login credentials (username and password) and access the Restricted Area. Please check that the e-mail address provided is correct in order to receive any future communication

Log in and access the Registered/Student Area, then select "**Admission**" from the menu tab and answer "Yes" to the following question: "*Are you an international student with a foreign degree, residing abroad, applying for a visa through the Italian Embassy/Consulate?*". Fill out the online application and attach the documents listed below:

1. **certificate of the qualification obtained:** this should indicate the type of study qualification, when and where it was obtained (in which university), **the final mark and the maximum mark allowed**, the list of examinations taken with the relevant marks. Students should attach a copy of the university diploma and any official document that may be useful to prove knowledge in the following fields: Business Administration, Marketing, Management, Economics, Statistics and Mathematics.
2. **an exam content outline** for each exam taken, in English
3. **a reference letter** (preferably written by a university professor) that may be attached to the online application or e-mailed by the Referee to [info.economia@unimore.it](mailto:info.economia@unimore.it)
4. **an international language certificate** at least a level B2 (Common European Framework of Reference) language certificate, or **alternatively a declaration issued by the home university** (language centre or department) on University headed paper, written in English and reporting the level obtained. A candidate who has obtained an English-taught Bachelor's Degree can submit a certificate issued by his/her University, stating that English is the medium of instruction in that university/course/faculty. This certificate is accepted as the proof of proficiency in English.

**ATTENTION:** only applicants who have submitted a suitable English proficiency certificate will be considered.

5. **European Computer Driving Licence (ECDL-basic level)** or, alternatively, the documents certifying the applicant's IT skills, if not indicated in the study programme
6. **Personal statement** written in English in which the applicant explains the reasons for applying
7. **Curriculum vitae**, written in English in accordance with the Europass model
8. **Any other qualifications** that applicants want to be considered for admission purposes (e.g. internships, university master programmes, further education, etc.).

**IMPORTANT:** the application is correctly submitted only **after saving the data and answering YES to the question "Do you want to submit your application now?"**

9. If you have saved the data and finalized the admission application **proceed with the payment of the € 20 fee**, available in ESSE3 on your personal page under the "Fees" section.

**ATTENTION:** the committee will not evaluate the academic records of students who do not pay by 20 February 2026 the €20 fee (non-refundable)

## 4. Admitted applicant ranking

The selection board, appointed by the Council of the "Marco Biagi" Department of Economics, examines the documentation attached to the application for the admission and draws up a ranking list based on merits.

The ranking will be available on the website <https://www.unimore.it/it/ateneo/bandi/2026-international-management-extruae-non-soggiornanti> by **15 April 2026**. It may be viewed only after logging in using the username and password received when submitting the online application.

The ranking criteria are as follows:

Study qualification and background (the committee may use the CGPA or the final mark to select the applications and candidates are also requested to indicate the maximum mark available); in addition IT skills and ECDL will be considered.	<b>0 – 90</b>

**The top 99 applicants in the rankings who have obtained a score higher than or equal to 78/100 will be admitted.**

UNICORE 8.0 - University Corridors for Refugees 2026-2027 ranking list, if UNIMORE participates in the project, will be published on <https://www.unimore.it/it/internazionalizzazione/progetto-unicore> The winning applicant will be ex officio admitted to International Management, for a total of **100 admitted applicants**.

On the other hand, applicants obtaining a score lower than 78/100 (i.e. up to 77/100) will not be admitted as they are not deemed suitable for enrolment and therefore finally excluded.

In the event of a tied score, precedence shall be given to the applicant with a higher score in the first section "Study qualification and background" and in suborder, to the youngest applicant.

The score will be assigned based on the documentation attached to the application for admission, and, if needed, applicants may be invited to take an **interview with the examining board to be held on on Skype, Meet, or Zoom**.

The knowledge of the English language at least of level B2 is an essential requirement.

If not clearly indicated in the study programme, the knowledge of the English language may be proven by means of international language certificates or declarations issued by the home University (language centre

or department) drawn on University headed paper, written in English and reporting the level obtained or indicating that English is the vehicular language of the degree programme (if it was delivered in English).

## 6. Application on Universitaly website for the purpose of obtaining the study visa

As indicated in the Italian ministerial circular for access to study programmes, which is published every year on the website [www.studiare-in-italia.it/studenti-stranieri/](http://www.studiare-in-italia.it/studenti-stranieri/), Non-EU applicants residing abroad must request a visa on the UNIVERSITALY platform (applications Academic Year 2026-2027) by clicking on the link <https://universitaly-private.cineca.it/index.php/login>

Their application is automatically sent to UNIMORE for validation. UNIMORE will notify the Italian Consular Authority in the event of admission to the study programme.

Applicants have to upload the following documents on the Universitaly platform:

- their passport
- their photo (passport size)

Any further documents relating to their academic qualification may also be attached, including:

- **declaration of value**, issued by the Italian Embassy/Consulate in the country to which the school issuing the qualification belongs  
*or, alternatively*
- **statements issued by ENIC-NARIC centres** such as the certificates released by CIMEA, as described in paragraph 7. Enrolment.

Please contact the reference diplomatic and consular representations as soon as possible to check the requirements and the documents needed for the visa to be issued.

## 7. Enrolment

Enrolment in the master's degree programme is allowed **from 8 July 2026 to 22 December 2026** to the students "admitted" in the rankings who:

- have completed the application on the Universitaly website
- obtain the entry visa in Italy for study reasons on time for the enrolment.

1. Bachelor degree diploma, translated and legalised by the Italian Embassy/Consulate
2. DECLARATION OF VALUE of the university degree, issued by the Italian Embassy/Consulate in the country to which the school issuing the qualification belongs, or alternatively, a declaration issued by ENIC-NARIC centres  
or, alternatively the following documents issued by CIMEA - <https://www.cimea.it/>:
  - a) STATEMENT OF CORRESPONDENCE downloaded directly by the candidate on the "Ardi" platform at <https://ardi.cimea.it/it> (for Lisbon Convention countries). If the country in which the degree was obtained is not among those listed on the "Ardi" platform CERTIFICATE OF COMPARABILITY to be requested from CIMEA by registering on the site <https://cimea.diplo-me.eu>.  
Attention: CIMEA does not issue the Certificate of Comparability if the Certificate of Correspondence is available.
  - b) CERTIFICATE OF VERIFICATION to be requested from CIMEA by registering on the <https://cimea.diplo-me.eu> website.

3. Degree certification, issued by the University awarding the degree
4. Receipt issued by the post office in Italy, certifying the filing of the application for a residence permit
5. Passport
6. Passport photo

After verifying the correctness and completeness of the documents submitted by the student, the Registrar's Office issues the slips for the tuition fee for A.Y. 2026-2027 and confirms the enrolment once the first instalment has been paid.

**Payments reporting a date later than 22 December 2026 on the receipt will not be deemed valid for enrolment purposes.**

**PLEASE NOTE** According to AgID (Agency for Digital Italy), the payment may be made by the payment service provider on the day following the payer's request. This would preclude the enrolment.

## 9. Tuition fees and benefits

In order to obtain an exemption from tuition fees or to request other additional benefits (scholarships, accommodation in a university residence, food services or other benefits), international students residing abroad and requesting a visa need to submit an online application by the end of August 2026. Online applications need to be submitted on the website [www.er-go.it](http://www.er-go.it) before enrolment.

The Call for Benefit Applications will be published approximately at the beginning of **June/July 2026**. Students are invited to check the various deadlines.
